Clubhouse:

Clubhouse rental is \$7759 for the year to date. There were 3 rentals in August for a total of \$850. September parties are currently at 3 as well for a total of \$1300.

Planting in the upper level of the front pond has been completed. Automatic sprinklers were installed by Carlos Valenzuela for \$170. Awaiting invoice for payment.

Our 2023 fire inspection has been completed and passed. Signage requested by SFD including updated capacity, chemical storage warning and prohibition of certain kinds of cooking were purchased and installed. Additionally the fire extinguishers were serviced on 7/28/23.

Pool:

The pool closed to families 9/3/23. The pop up tents and most of the furniture have been take down and put in storage.
